- *State v. Center for Excellence in Higher Education*, P.3d (Colo. App. 2021). Reversal of a multi-million dollar judgment in an Attorney General lawsuit against a proprietary college.
- *Schaden v. DIA Brewing Co.*, 478 P.3d 1264 (Colo. 2021). Reversal of an order dismissing an amended complaint alleging major bid-rigging at Denver International Airport (DIA).

- *People v. Brooks* (Colorado Supreme Court No. 18SA90). Represented Curtis Brooks who was sentenced to life imprisonment as a juvenile before SB16-181 was passed, making the sentence unconstitutional. The case ended with gubernatorial clemency granted for Brooks.
- *Ghailani v. Sessions*, 859 F.3d 1295 (10th Cir. 2017). Represented Muslim inmate at Colorado Supermax in successfully overturning dismissal of religious freedom complaint seeking group prayer rights.
- *AVS Residential Condo Ass'n v. Arrabelle at Vail*, 382 P.3d 1275 (Colo. App. 2016). Represented homeowners association in successful appeal against Vail Resort in case raising important issues of first impression regarding rights under common interest ownership law.

- *Leone v. Owsley*, 810 F.3d 1149 (10th Cir. 2015). Convinced Tenth Circuit to overturn summary judgment order and then took on lead responsibility in federal jury trial resulting in \$1.9 million verdict for client. Case reported on in feature story in Denver Business Journal.
- *U.S. ex rel. Little v. Shell Oil*, 602 Fed. Appx. 959 (5th Cir. 2015). Successfully represented False Claims Act plaintiffs in overturning summary judgment and ordering case reassigned to new trial judge. Case reported in Law 360.

The Tenth Circuit's eloquent opinion sets an important precedent recognizing prison inmates' rights to exercise their religious beliefs.
